# **Club Regulations and Bylaws**

## **Article 1: Name**

1. The Finger Lakes Region Volkswagen Club Incorporated.

## **Article 2: Purpose and Direction**

1. To promote camaraderie and enjoyment of Volkswagen ownership.
2. To share information and experiences between members pertaining to Volkswagens.
3. To promote Volkswagen events, e.g. road rallies, swap meets, car shows, etc.
4. To participate in car shows and parades to better enhance and publicize our Club.

## **Article 3: Authorities of Club**

1. To be independent and without affiliation with Volkswagen of America, its representatives, or any other organization.
2. To incorporate under the laws of New York.
3. To adopt bylaws.
4. To have control over unacceptable conduct that may tarnish the image of the Club.
5. To have the right to dismiss any member of guest off a member who abuses mind-altering substances, whether legal or illegal, that would impair the judgment and/or moral conduct.

## **Article 4: Membership**

1. Membership is open to anyone who has an interest in Volkswagens, regardless of national origin, race, color, religion, sex, gender identity, age.

## **Article 5: Officers and Elections**

1. The Board of Directors will be the governing body.
2. The Board of Directors consists of an unlimited number of members volunteering for the position at the annual Board of Directors meeting in January.

## **Article 6: Dissolution**

1. At least two-thirds of the members must vote in favor of dissolution, in which case proper notification will be given to the State of New York.
2. If dissolution is approved, all assets will be divided equally amongst all registered members. The existing Treasurer will make the division of assets.

## **Article 7: Amendments**

1. All amendments proposed by the Board of Directors must be endorsed by two-thirds vote in favor of the proposed amendment.
